2021 Food Vendor Rules & Regulations

Deadline

The deadline to submit Food Vendor applications to Livin' Out Loud (LOL) will be August 1, 2021. Space is limited and there is no guarantee that space will be available after the deadline submission date. In the event an application is received prior to the deadline and payment is made in full, that will not constitute LOL's acceptance of the application. Acceptance of any applications submitted to LOL will be made as stated herein.

Acceptance

Food Vendors understand that acceptance of applications are within the sole discretion of LOL. Further, in the event LOL accepts the application, the Food Vendor shall be bound by the terms stated herein. In the event applications are not accepted by LOL, Food Vendor site fees will be returned and Food Vendors will not be bound by the terms stated herein. Acceptance of applications will be made via email by LOL on or before fifteen (15) days prior to the first day of the event. LOL reserves the right to refuse any Food Vendor's application including applications that do not meet the standards set for the event.

Site Fee

Food Vendors shall pay a fee of \$250 for the first 20 foot space stated above in accordance with the terms stated herein. If additional space is required, each additional 20 foot adjacent space will be \$150. Food Vendor fees will be paid upon application approval. The fees are not a deposit nor is any portion thereof to be refunded to Vendors in the event the Application is accepted by LOL. In the event the Application is not accepted by LOL, all fees paid with the Application shall be refunded to Vendors. If Vendor application is accepted, the space assigned and all fees previously paid will be forfeited as liquidated damages if the space is not occupied by 4:30 p.m. the day of event.

Requirements

Vendors are required to have a valid food service license from the Nebraska Department of Agriculture. If you don't have one, you may view the temporary vendor requirements online at www.nda.nebraska.gov or call (402) 471-3422.

Sales Tax

Vendors hereby agree to collect any and all applicable Taxes, and that LOL does not accept or assume any responsibility for state, local and/or federal taxes required or the collection of those taxes. Sales tax are approximately between 7-9% payable to the State of Nebraska. LOL will provide you with the appropriate paperwork. **However, the Vendors are solely responsible for submitting the form and payment to the State of Nebraska Department of Revenue.**

Prices Advertised

Vendors MUST post prices for all food and drink items in an area that allows customers to know the cost of what they are purchasing.

Beverages and Ice

Alcoholic beverages are not allowed for sale prior to or during the event. Ice will not be provided by LOL and Vendors should plan accordingly based on their needs.

Set Up

Vendor booths are assigned upon application approval and all Vendors MUST check in with Teresa or Connie upon arrival at the venue to set up their space. Vendor sites will be located in a pre-determined area designated by LOL. Set up time for Food Vendors shall be Friday, August 20 from 4:00 p.m to 8:00 p.m. and Saturday, August 21 from 7:00 a.m. to 4:00 p.m. Vendors are required to bring their own structures, furniture, electrical source (generators) and lighting for all vendor operations. Vendor site will have vehicle accessibility for load in and load out on a gravel road. Driving on the grass is prohibited. After load in, vehicle must be moved. No parking will be allowed in Fire Lane. LOL accepts no responsibility for vehicles/trailers left on park premises after 8:00 p.m. Friday until 7:00 a.m. Saturday.

Vendors must keep their sales area clear of empty boxes and trash and have adequate garbage containers. Storage work areas behind booths must be kept orderly.

All buildings, tents, signs or enclosures put up under the terms of this agreement must have the approval of LOL. Any tent stakes must have safety coverings on them. NO loud speaker, amplifier, radio or other sound device can be used at the Vendor's site without consent of LOL.

Site Hours

Friday, August 20, 2021 4:00 p.m. to 8:00 p.m., and Saturday, August 21, 2021 7:00 a.m.. to 11:00 p.m. All Vendor booths must be open and staffed during the hours of 5:00 p.m. and 11:00 p.m. unless otherwise approved by LOL. These are the minimum hours of operation during the event. LOL concert will begin at 4:45 p.m. on Saturday.

Vendor agrees to not take down or remove sales exhibits during the event, unless otherwise approved by LOL.

LOL Discretion

Vendor acknowledges its understanding that LOL comes together with the Christian community of Gothenburg and surrounding areas to put on a free concert. As a Christian non-profit, LOL reserves the right to make selections of Vendors and their merchandise consistent with LOL's mission and objectives. LOL also reserves the right to ask for the removal of any product that is not consistent with said mission and objectives. LOL also reserves the right to close any vendor site for any safety, product or service quality issues. LOL reserves the right to grant to any Vendor the exclusive rights to distribute and/or sell any product during the event.

Vendors agree that any representative of LOL that oversees the Vendor spaces shall have free access to said premises at all times.

Vendor Risk

Vendors hereby agree that all personal property, supplies, equipment, product and merchandise in or around the Vendor area shall be on site at its own sole risk and hazard. Vendors hereby agree to indemnify and hold LOL harmless from any and all claims, cause of action, suits or demands for liability, damage, loss, expense arising from any injury to persons or property which may occur in relation or

connection to Vendors, their agents, representatives, employees, guests or customers activities, acts, actions, failures or omissions in relation to the event at any time before, during or after the same. Vendors acknowledge that LOL has informed them that the sites are not secure facilities and that LOL does not guarantee the security or safety of Vendor's property, assets or sales receipts, and Vendors hereby agree to accept full responsibility for the same.

Check Out

Vendors MUST check out with an LOL representative prior to tearing down and leaving the event grounds. An additional fee may be charged if the site is not clean prior to check out. **All product and furnishings must be removed from the event grounds by 1:00 a.m. Sunday morning unless prior approval from LOL is obtained.**

Tear Down

Vendors may begin tearing down their booths Saturday, August 17 at 11:00 p.m. However, for safety reasons, **no vehicles will be allowed on event grounds, in the area around the Vendor tents until ½ hour after the concert has completed.**
